

Local Law 93 of 2015 (Previously Local Law 6 of 2011) – Biannual Report

Pursuant to Local Law 93 of 2015, the Department of Education is required to provide reports on student discipline data (suspension data) to the City Council twice a year (October 31 and March 31). The October reporting requires citywide suspension data by month for the second half of the academic year, January through June. Per the legislation and in accordance with the Family Educational Rights and Privacy Act (FERPA), any value from zero (0) to five (5) has been redacted.

Data from January – June 2018, when compared to the same time period last year, January – June 2017, shows a decrease of 4.6% in total suspensions. Principal suspensions decreased by 4.9% and superintendent suspensions decreased by 3.8%.

In school year 2017-2018, when comparing the full school year (September 2017 to June 2018), we saw an increase of 4.1% in total suspensions with principal suspensions increasing by 3.4% and superintendent suspensions increasing by 5.8%.

The October reporting requires EMS data disaggregated by district and by month for the second half of the school year (January to June). Per the legislation and in accordance with the Family Educational Rights and Privacy Act (FERPA), any value from zero (0) to five (5) has been redacted.
